**ARTICLES OF INCORPORATION**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE 1 - NAME**

The name of the Corporation is: Barbara W. Bronis, P.A.

**ARTICLE 2 - DURATION**

The duration of the Corporation is perpetual.

**ARTICLE 3 - PURPOSE**

The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.
- C. To engage in the practice of law.

**ARTICLE 4 - CAPITAL STOCK**

The aggregate number of shares which the Corporation is authorized to issue is 5000 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

**ARTICLE 5 - PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal office and mailing address of the Corporation is 3543 S.W. Sunset Trace Circle, Palm City, Florida 34990.

ARTICLE 6 - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE 7 - INITIAL BOARD OF DIRECTORS

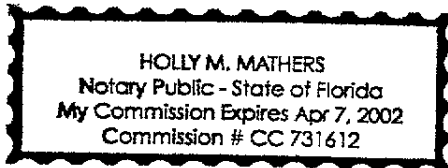
