# ARTICLES OF INCORPORATION OF COICOI CORPORATION

We, Rodolfo Alvarez Checa and Concepcion Teresa Vis de Alvarez, the undersigned, being of legal age and natural persons, do hereby subscribe to, acknowledge, and file the following articles of incorporation for the purpose of creating a corporation under the laws of the state of Florida.

1. The name of this corporation shall be Coicoi Corporation.
2. The purpose of this corporation shall include the transaction of any and all lawful business for which corporations may be incorporated under chapter 607, Florida Statutes.
3. The aggregate number of shares which this corporation shall be authorized to issue is sixty (60) shares. Said shares shall consist of one class only and all such shares are \$.10 par value. *JA*
4. This corporation shall commence its existence immediately upon the filing of these articles of incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.
5. The address of the principle office of the corporation and the mailing address of the corporation shall be 3414 Sands Harbor Trace, Pompano Beach, Florida 33069. 

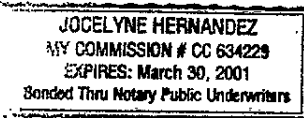
