

ARTICLES OF INCORPORATION
OF

I. NAME

The name of the corporation is INTERNATIONAL HEALTH NET, INC.

II. TERM OF EXISTENCE

This corporation shall have perpetual existence.

X. AMENDMENTS

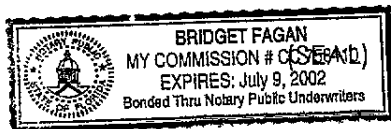




