The undersigned incorporators hereby form this following corporation under the laws of The State of Florida.

**ARTICLE I
NAME OF CORPORATION**

The name of this corporation is: Westen Corporation.

**ARTICLE II

**ARTICLE III
NUMBER OF SHARES**

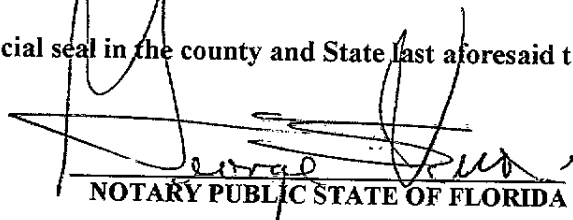

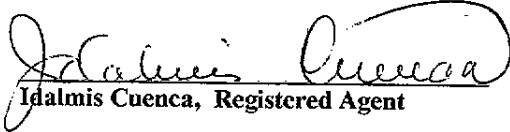
