The name of the corporation is **Towne Development of Town Center, Inc.**

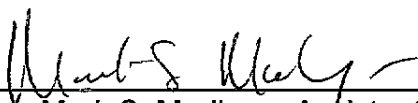
THIRD: The Amendment to the Articles of Incorporation was adopted by the unanimous consent of the shareholders of the corporation on July 26, 1999.
