ARTICLES OF INCORPORATION

MARTIN HERNANDEZ and IDANIA HERNANDEZ, the undersigned, hereby associate, BLACKDIAMOND DRILLING, INC., for the purpose of becoming a corporation for profit under the laws of the State of Florida, and do certify that BLACKDIAMOND DRILLING, INC., has become such corporation under and pursuant to the following Articles of Incorporation.


