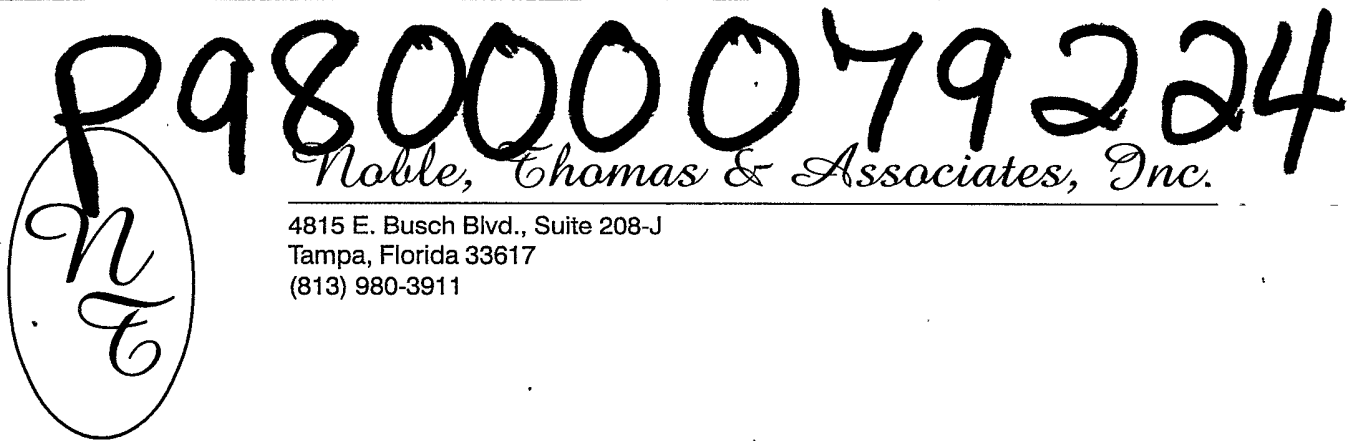

**ARTICLES OF INCORPORATION  
OF PROPHETE & AVENA SUPERMARKET, INC.**

**ARTICLE I. CORPORATE NAME**

The name of this corporation is: PROPHETE & AVENA SUPERMARKET, INC., where the principal office is: 1226 Edgerton Drive, Valrico, FL 33594.

**ARTICLE II. NATURE OF BUSINESS AND POWERS.**

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

**ARTICLE III. CAPITAL STOCK.**

The aggregate number of shares which this corporation shall have authority to issue is 2,500 shares of common stock having a NON Par value per share.

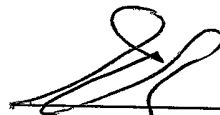

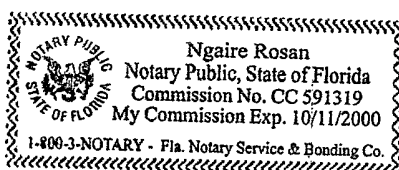
