ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

C. The name and address of the initial members of the Board of Directors, who shall hold office until his successor is duly elected and qualified is:

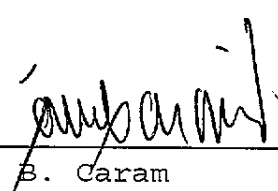

The above stated amendments were approved by unanimous consent of all shareholders entitled to vote.

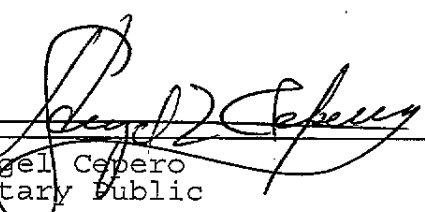
