1. Clifford Narinesingh is the President of DWIGHT SHEFOD IMPORT/EXPORT, INC., a Florida corporation, (hereinafter "Corporation").
2. That the Corporation was administratively dissolved by the Florida Department of State on 24 Sept. 1999 .
3. That the Corporation failed to file its 1999-2005 Annual Report or pay the 1999-2005 Annual Report filing fee within the time prescribed by Florida Statutes Chapter 607 because:
 - 3.1 the written notice and requirements for filing the Annual Report and pay the Annual Report fee to the Florida Department of State was never received by the Corporation; and,

6. No further ground or grounds exist for the administrative dissolution of the Corporation.

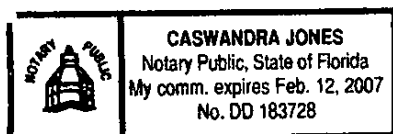
