# ARTICLES OF INCORPORATION EMERALD COAST LIMOUSINES, INC.

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

## ARTICLE ONE

The corporate name is, **EMERALD COAST LIMOUSINES, INC.**

## ARTICLE EIGHT


The power to make, alter, amend and repeal the bylaws of the corporation shall be reserved to the stockholders.
