*Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:*

**FIRST:** Amendment(s) adopted:

**ARTICLE I - NAME** is amended to read as follows: The name of this corporation shall be and is DAVID R. SILVER, M.D., P.A.
