**ARTICLE I**

**NAME**

The name of this corporation is J.K. RUTLEDGE ENTERPRISES, INC.

**ARTICLE II**

**DURATION**

This corporation shall exist perpetually.

**ARTICLE III**

The corporation shall indemnify any officer or director or incorporator or former officer, director or incorporator, to the full extent permitted by law.


**ARTICLE IX**
