ARTICLES OF INCORPORATION

OF

RICTUR, INC.

ARTICLE I - NAME

The name of the corporation is RICTUR, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the State of Florida, Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any lawful business.
