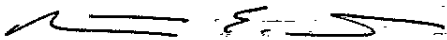

ARTICLES OF INCORPORATION
OF
RANMARK HOTEL & RESTAURANT SUPPLIES, INC.

ARTICLE I - NAME

The name of this corporation is RANMARK HOTEL & RESTAURANT SUPPLIES,
INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of
these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for
which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or
may after be amended.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one thousand shares of one dollar (\$1.00) par
value common stock which shall be designated as "common shares."

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT AND PRINCIPAL OFFICE AND MAILING ADDRESS

The street address of the initial registered office of this corporation is 745 12th Avenue South, Ste. B, Naples, Florida 34102 and the name of the initial registered agent of this corporation at that address is Christopher E. Mast, Esquire. The street address of the principal office is 5901 Shirley Street, Naples, Florida 34109 and the mailing address is the same.

ARTICLE VII - BOARD OF DIRECTORS

This corporation shall have two directors constituting the initial Board of Directors. The number of directors may be either increased or decreased from time to time by vote of the shareholders, however, there shall never be less than one director nor more than five.

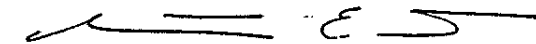
