**ARTICLES OF INCORPORATION  
OF  
G-P 2NH6 GROUP X, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I**

**NAME**

The name of the corporation is G-P 2NH6 Group X, Inc.

**ARTICLE II**

**PRINCIPAL OFFICE AND MAILING ADDRESS**

The corporation's activities will be limited to the following:


- A. The corporation shall not engage in any business activity other than holding its interest in 2NH6 Group X, Ltd., a Florida limited partnership.
