The letter acknowledges receipt of \$450.00 filing fees for the three corporations, however, states the report has not been filed because it was late and I owe late fees on all corporations.

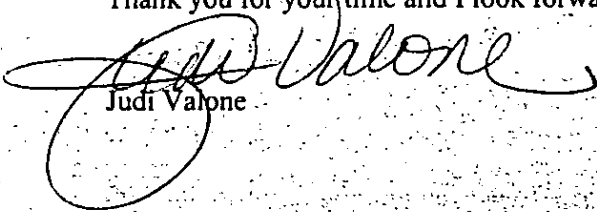
