**ARTICLE I**

**NAME**

The name of the Corporation is **Teri M. Fisheries, Inc.** The principal office address and the mailing address of said Corporation is 1473 Cove Landing Drive Atlantic Beach, Florida 32233.

**ARTICLE II**

**DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

**ARTICLE III**

**PURPOSE**
