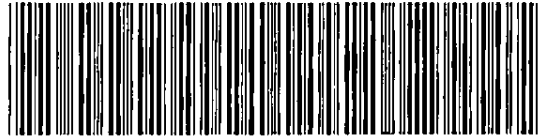

Pursuant to the provisions of Section 607.1006, Florida Statutes, the Articles of Incorporation of the above-named corporation (the "Corporation"), filed with the Department of State on September 16, 1998, and assigned Charter Number P98000079904, are hereby amended pursuant to a written consent in lieu of meeting executed by the holders of all of the Corporation's Common Stock and all of the Corporation's Directors on the 31 day of January, 2024, as follows:

ARTICLE I

ARTICLE III is hereby amended to read as follows:

CAPITAL STOCK

This Corporation is authorized to issue five hundred thousand (500,000) shares of .0001 par value common voting stock and five hundred thousand (500,000) shares of .0001 par value non-voting common stock.

ARTICLE II

This Amendment to the Articles of Incorporation was adopted by the shareholders and directors on the 31 day of January, 2024. The number of votes cast for the amendment by the shareholders was sufficient for approval.

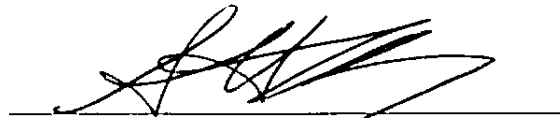
