The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is Safe-One Alarms, Inc. whose principal place of business is 4747 Nob Hill Road, Ft. Lauderdale, Florida 33351.

ARTICLE II

The period of duration of the corporation is perpetual.

ARTICLE III
