The undersigned incorporator hereby forms a corporation under chapter 607 of the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: " A & Y FOOD MART, INC. "

The Address of the principal office of this corporation shall be: 3401 N. 22nd Street, Tampa, Florida 33605. The mailing address shall be the same as the principal address.

ARTICLE II - NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities of business permitted under the laws of the United States of America, the State of Florida, or any other state, country, territory or nation legally and lawfully instituted. The primary function of this corporation shall be that of convenience stores and its sub-ramifications.

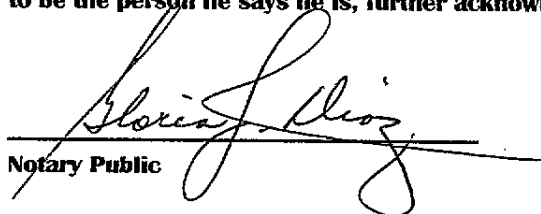
