BY THESE ARTICLES OF INCORPORATION, the incorporator forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is

BIOSCIENCE PRODUCTIONS, INC.

ARTICLE II - TERM OF EXISTENCE

This Corporation shall commence upon filing of these Articles with the Department of State and shall exist perpetually.

ARTICLE III - PURPOSE

The purpose for this corporation is:

A. To purchase, produce, publish, and/or sell manuscripts, books, videos, audio tapes, movies and screen plays of every kind.

B. To transact any or all lawful businesses for which corporations may be formed under the laws of the State of Florida.

ARTICLE IV - CAPITALIZATION

This Corporation is authorized to issue 10,000 shares of common stock of a par value of \$.10 per share.

ARTICLE V - DIRECTOR

This Corporation shall have one director initially. The number of directors shall be fixed by the Bylaws and may be changed from time to time.

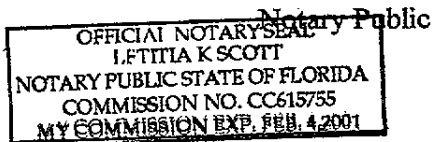

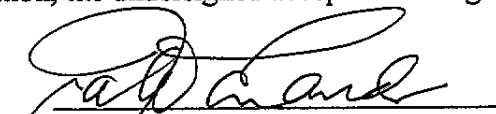
