Dear Sir or Madam:

Enclosed is our annual report (which was returned by the Florida Department of State) and your letter (sent with our returned report) indicating that an additional fee is due for being late.


Please be advised (this is the second written communication on this subject) that the original report was never received for the business despite the fact that we had advised the UBR Division/Division of Corporations of a change of address. Upon the realization that the report had not been received we informed the UBR Division/Division of Corporations at which point the Division mailed us a blank form (not even an original pre-filled form). Upon receipt of the blank form we immediately completed it and returned the form.

Based on historical experience with the UBR Division/Division of Corporation I have personally been involved in situations where the division has waived the \$400.00 late fee upon request based on unusual circumstances. Considering the circumstances surrounding this situation we respectfully request that the Division of Corporations accept the traditional filing fee of \$150.00 each plus \$8.75 each for certificate (previously a check was submitted for these amounts). The imposition of the \$400.00 late fee would create an extreme financial burden on the organization.

In addition, as further proof of our claim that documents have not been mailed to our correct address, you will find attached a June 16, 2000 letter from the Florida Department of State indicating the certification status of DiTocco Development (a sister company). Despite the department receiving the annual report with the correct mailing address, the department still mailed the certification letter and actual certification report to the wrong address. Why?
