**ARTICLES OF INCORPORATION
OF
FLORIDAYS, INC.**

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I - Name

The name of the corporation is **FLORIDAYS, INC.** The principal place of business of the corporation is 621 East Cape Coral Parkway, Cape Coral, Florida 33904. The mailing address of the corporation is c/o Mr. W. Engel, 621 East Cape Coral Parkway, Cape Coral, Florida 33904.

ARTICLE II - Commencement and Duration

The corporation is to commence its corporate existence on the date of filing, and shall exist perpetually thereafter until dissolved according to law.

ARTICLE III - Purpose

The corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - Stated Capital - Classes of Stock

The corporation is authorized to issue 1000 shares of common stock at \$1.00 par value.

ARTICLE V - Stock Ownership
