ARTICLES OF INCORPORATION

OF

AMAZING EVENTS, INC..

Article I - Name

The name of this corporation is AMAZING EVENTS, INC..

Article II - Duration

This corporation shall exist perpetually commencing on September 1, 1998.

Article III - Purpose

This corporation is organized:

1. To manufacture, construct, purchase or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with products, goods, wares, merchandise, real and personal property and services of every kind, class and description.

2. To engage in any activity or business permitted under the laws of the United States and of this State, as the same may be from time to time amended.
