**ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

**FIRST:** The name of the corporation is **SOUTHERN MUSIC SUPPLY, INC.** The address of the principal office of this corporation shall be Southern Music Supply, Inc. c/o Law Offices of Marjorie E. 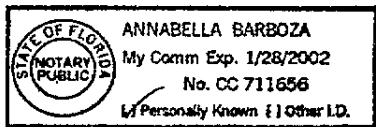
