ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Rose's Cookies, Inc.

The corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.


ARTICLE X - AMENDMENT
