

**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - CORPORATE NAME

The name of this Corporation shall be NEW VIEW KITCHENS, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and the mailing address of the corporation shall be 6708 Lorraine Road, Bradenton, Florida 34202.

ARTICLE III - CAPITAL STOCK

The number of shares of stock that this corporation is authorized to have outstanding at any one time is one hundred (100) shares of common stock having a par value of \$1.00 per share.

ARTICLE IV - PURPOSE

The purpose of this corporation is to engage in any and all business permitted under the laws of the United States and of the State of Florida.

This Corporation shall have a perpetual existence.


ARTICLE VIII - AMENDMENT


ARTICLE IX - AMENDMENT OF BY-LAWS




