ARTICLE I

CORPORATE NAME AND PRINCIPAL PLACE OF BUSINESS

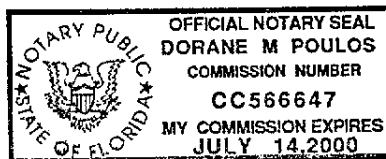
