The undersigned incorporator, for purposes of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

- FIRST: The name of the Corporation is BUC WEB SERVICES, INC. (the "Corporation").
- SECOND: The street address of the initial principal office and mailing address of the Corporation is 1314 Northeast 17th Court, Fort Lauderdale, Florida 33305.
