The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be: SQUARE INCH, INC. The principal place of business of this corporation shall be 2247 Palm Beach Lakes Blvd., Suite 237, West Palm Beach, Florida 33409.

ARTICLE II. NATURE OF BUSINESS
