ARTICLE I
NAME AND PRINCIPAL OFFICE

EFFECTIVE DATE

The name of this corporation is International Marine Management Associates, Inc. and its initial principal office is located at 1408 Brickell Bay Drive, Suite 1211, Miami, Florida 33131.

ARTICLE II PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE III DURATION
