## ARTICLES OF INCORPORATION

OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- 1. The name of the Corporation shall be CAPITOL DATA SYSTEMS, INC. (hereinafter referred to as the "Corporation").
- 2. The purpose or purposes for which the Corporation is organized are the transaction of any and all lawful business, not required to be specifically stated in these Articles of Incorporation, for which corporations may be incorporated under the Florida Business Corporation Act, including, without limitation, the providing of wholesale computer services.
