**ARTICLES OF INCORPORATION  
OF

**The undersigned files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida:**

**Article I**

**The name of this corporation shall be AGRIFOOD NETWORK, INC. The existence of this corporation shall commence upon the filing of these Articles of Incorporation and shall continue perpetually unless dissolved according to law.**

**Article II**



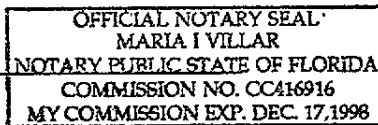
