CERTIFICATE OF INCORPORATION

OF

WE, the undersigned, in order to form a corporation of the purposes hereinafter stated, under and pursuant to the provisions of the Florida Statutes, do hereby subscribe to this Certificate of Incorporation, and do adopt the following Articles of Incorporation:

ARTICLES OF INCORPORATION

ARTICLE I.

The name of this Corporation shall be: New Future Staffing, Inc.

The general nature of the business and the objects and purposes to be transacted and carried on by this corporation shall be:


