ARTICLE I. NAME

The name of this corporation is Sarah Armstrong, Inc.

ARTICLE II. DURATION

This corporation shall exist perpetually. Corporate existence shall commence with the filling of these articles with the Department of State.

ARTICLE X. AMENDMENT

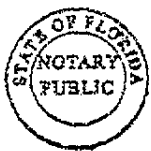
