

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

## ARTICLE I

The name of the Corporation shall be RASOR TRANSPORT, INC.

# ARTICLE II

The principal place of business and mailing address of this corporation shall be 930 S. Harbor City Blvd., Suite 505, Melbourne, Florida, 32901.

### ARTICLE III
