
ARTICLE IX

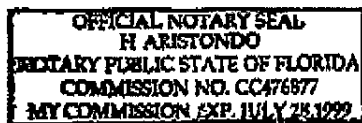


