ARTICLES OF INCORPORATION

OF

Quickcreative Corp.



The undersigned, Lisa Laughton, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be Quickcreative Corp., a Florida corporation.

ARTICLE II PRINCIPAL OFFICE
