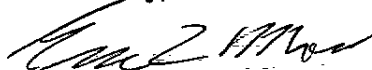

OF

ARTICLE ONE
NAME OF CORPORATION

The name of the corporation is 600 Reef Road Inc.

ARTICLE TWO
DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these articles with the Department of State.

PURPOSE

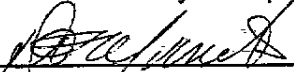

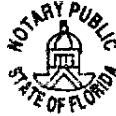
