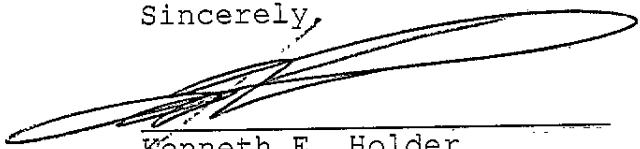

The undersigned, acting as incorporator of a Florida corporation, hereby adopts the following Articles of Incorporation for such Corporation:

Article I

The name of the corporation is:

Article III

Purpose

The Corporation is organized for the purpose of engaging in or transacting any and all lawful activities or businesses permitted under the laws of the United States, the State of Florida, or any other state, country, territory, or nation.

Amendments

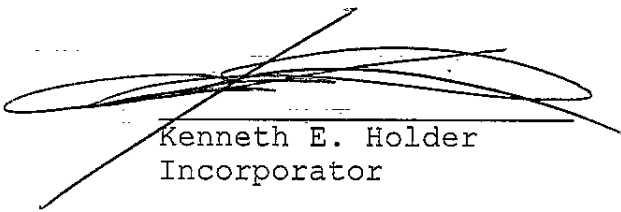
