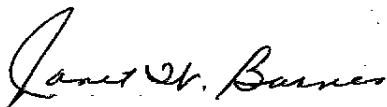

OF

ARTICLE VI

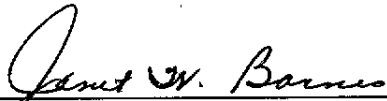
BOARD OF DIRECTORS: The initial board of directors shall consist of one (1) member. The name and address of this individual who is to serve as the director is as follows:
