ARTICLES OF INCORPORATION
OF
CLEARVIEW GROUP, INC.

ARTICLE ONE

The name of the corporation is Clearview Group, Inc.. The principle office is located at 11110 W. Oakland Park Blvd., Suite 196, Sunrise, Florida 33351.

ARTICLE TWO

The period of duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.
