ARTICLES OF INCORPORATION

OF

CAKE BOUTIQUE & MORE, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Cake Boutique & More, Inc.. and its address is P.O. BOX 522144, Miami, Florida 33152-2144.

ARTICLE II

DURATION

The duration of the corporation is perpetual.

ARTICLE III

PURPOSE

The general purpose for which the corporation is organized are:
