The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME AND PRINCIPAL OFFICE

The name of this corporation is BELAIR BUSINESS, INC., and its principal office is located at 30 South Spring Street, Pensacola, Florida 32501, and its mailing address is the same.

ARTICLE II

DURATION

This corporation shall exist perpetually, commencing upon the date of filing of these Articles of Incorporation.

INITIAL REGISTERED OFFICE AND AGENT

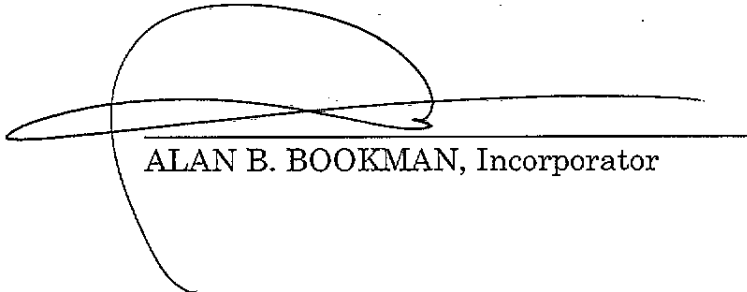
