ARTICLES OF INCORPORATION
OF
PRO-TRIM LAWN CARE, INC.

The undersigned incorporator to these Articles of Incorporation, a natural person competent to Contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is: Pro-Trim Lawn Care, Inc.

ARTICLE II

The general nature of the business to be transacted by this corporation is:

To engage in any activity or business permitted under the laws of the United States and of this State.

To the same extent as natural persons might or could do, to do any activity relating to maintaining Lawns, such as mowing, trimming, edging, etc. as required of a lawn maintenance business.

To exercise all the powers now granted to this type of corporation under Florida law, and all Powers subsequently authorized or granted by law to private corporations.

The foregoing clauses shall be construed both as objects and powers, and it is hereby expressly Provided that the foregoing enumeration of specific powers shall not be held to limit or restrict In any manner the powers of this corporation.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to have outstanding At any one time is:

100 Shares of Common Stock of Non-Par Value

The shareholders shall have preemptive rights.

Cumulative voting shall not be permitted.

The shareholders may, by by-law provision or by written shareholder's agreement, impose Such restrictions of the sale, transfer, or encumbrance of the stock of this corporation as they may See fit.

ARTICLE IV

This corporation is to exist perpetually, and its corporate existence shall begin upon filing

ARTICLE V

The Board of Directors may from time to time move the principal office to any other address In Florida. The initial address of the principal office of this corporation in the State of Florida is:

The number of directors may be increased or diminished from time to time by By-Laws adopted By the Stockholders, but shall never be less than one. Initially, the number of directors shall be two.
