


ARTICLES OF INCORPORATION



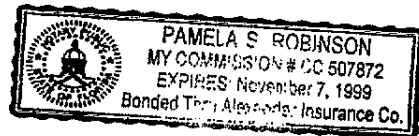


