**ARTICLES OF INCORPORATION**  
**OF**  
**CLARKSON – HOLLINGSWORTH LANDSCAPE DESIGN, INC.**

**ARTICLE I - NAME:**

The name of this corporation is ***CLARKSON-HOLLINGSWORTH LANDSCAPE DESIGN, INC.***

**ARTICLE II - DURATION:**

This corporation shall commence on the date of filing of these articles with the Secretary of State and shall have a perpetual existence.

**ARTICLE III - PURPOSE:**

This corporation is organized for the purpose of transacting any lawful business for which corporations may be incorporated under the Florida General Corporations Act and to do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

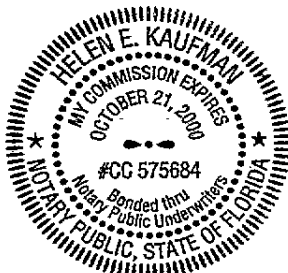
