ARTICLE I - NAME

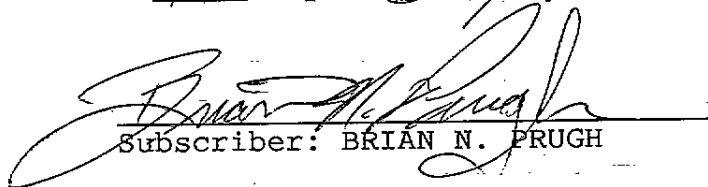
#### ARTICLE IX - INDEMNIFICATION

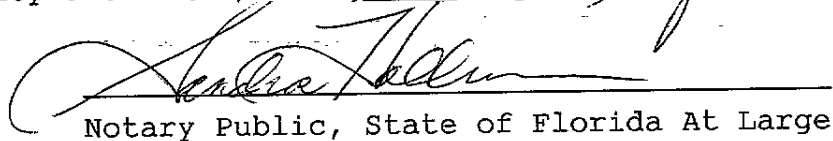

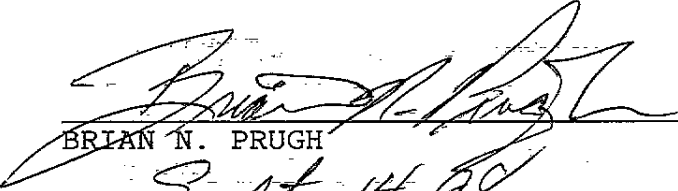
