

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

1. The name of the corporation is Gale Lister & Associates, Inc.
2. The period of its duration is perpetual.
3. The purpose of the corporation is to engage in promoting, marketing, remodeling of commercial and residential property and to engage in any businesses or activities which are permitted under the laws of the United States and the State of Florida.
4. The corporation shall have authority to issue 10,000 shares of one dollar par value common stock.
