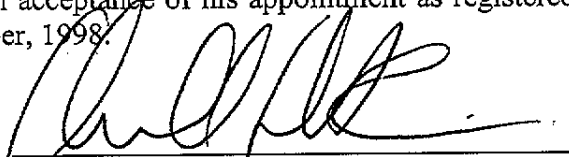
### ARTICLE X - INDEMNIFICATION
